AGREEMENT: The Agreement between Purchaser and Music Together LLC shall consist of these Terms and Conditions and any specifications or other written terms and conditions specifically incorporated into the Agreement. Any purchase order, acknowledgement of order by any means, or other instrument of acceptance of the goods and services provided hereunder by Purchaser shall be construed as acceptance of this Agreement.

WHOLESALE ONLY: Purchaser must include a copy of the company's resale license with the initial order to verify status as a wholesale dealer.

PAYMENT TERMS: All initial orders are prepaid. To be billed, please request a credit application. Normal terms for invoices are net 30 days. No shipments will be made to a past due account. A 1.25% monthly finance charge will be added to all overdue balances.
